

# MAJORS GUN-A-Month CLUB 2012 DRAWINGS

## Sample Prizes

## TERMS:

Drawings start once minimum sales goal of 450 tickets (6 prizes) is achieved (no earlier than January)

\*One EXTRA prize added for every 50 tickets sold beyond minimum sales goal of 450 tickets

\*Each EXTRA prize will extend the drawings by one month (max four extensions or October)

\*Total ticket sales will determine if drawings runs through October (final month)

Final prize selection list may vary depending on total ticket sales and prize availability

All prizes randomly chosen from prize selection list the month prior (first month/BONUS prize pre-designated)

Once a prize is won, it is removed from the prize selection list

BONUS drawing added if cost average of awarded prizes is below budgeted amount

\*\* Initial distribution limit is 650 tickets (10 prizes valued up to \$1400)

100 ticket lots (2 extra prizes per lot) MAY be added if all previously distributed tickets sold before first drawing

Odds: 1:75 (450 tickets/6 prizes); 1:68.75 (550/8); 1:65 (650/10); 1:62.5 (750/12); 1:60.1 (850/14); etc

Tickets sales continue until limit is reached and ticket price will NOT be prorated once drawings begin

One prize per customer per year; need not be present to win

Winner must claim prize within 30 days or before the next MGC meeting (waived for travel)

**BOTTOM LINE: Lots of prizes; the more prizes added, the better the odds**

## Drawing Rules

Firearm prizes must be claimed IN PERSON by the actual winner (name on the ticket) at the Designated FFL Dealer. **NO exceptions!**

Winner need not be present at the drawing to win. No ticket holder may receive more than one prize per year.

The ticket holder is responsible to ensure that adequate contact information is on the ticket stub retained by MAJORS GUN CLUB. The information on the ticket stub will be used to contact prize winners. If MAJORS GUN CLUB is unable to contact a prize winner within 30 days of the drawing or by the date of the MAJORS GUN CLUB meeting after the drawing (whichever comes first) the prize is forfeit.

Any prize not claimed within 30 days of the drawing or before the date of the next MAJORS GUN CLUB meeting after the drawing (whichever comes first) is forfeited. This requirement waived for winners unavailable due to travel.

If the winner is not eligible to receive the prize, (e.g. Unable to pass the NICS check to claim a firearm prize) the prize is forfeit.

Winners who forfeit prizes are not eligible for a refund of ticket purchase costs.

In the event of a forfeit prize, a second drawing using the same tickets but with the original winner(s) ineligible will be held at the next MAJORS GUN CLUB meeting after the original drawing to distribute any unclaimed prizes.

Majors Gun Club Executive Committee reserves the right to make special exceptions to these rules in the event of hardship situations that obviously warrant leniency. Examples include but are not limited to: Extended business travel, unforeseen severe health problems, financial difficulties, etc.
